

PAANK MONTHLY REPORT (APRIL) 2025





Executive Summary

This report documents serious human rights violations committed in Balochistan during April 2025, including enforced disappearances, extrajudicial executions, and systemic torture. The information herein is collected and verified by Paank.

Key Findings

- Total Enforced Disappearances: 151 cases reported
- Torture Survivors Released: 50 individuals
- Extrajudicial Killings: 23 cases documented

These figures indicate a sustained and deliberate campaign of repression, disproportionately affecting Baloch population across multiple districts.





Enforced Disappearances

Reports indicate a surge in enforced disappearances across at least 18 districts. The highest number was reported from **Kech (53 cases)**, followed by **Gwadar (19)** and **Quetta (18)**. Disappearances were frequently followed by incommunicado detention and, in several cases, extrajudicial execution.

Note: Several individuals remain in illegal custody at various police stations or military dungeons. Many more may have been injured or abducted during violent operations. Comprehensive data remains incomplete.



Conclusion & Recommendations

The pattern of violations outlined in this report reveals systemic abuse and a culture of impunity enabled by state institutions. Paank, urges:

Independent international investigations into enforced disappearances and extrajudicial killings.

Immediate disclosure of detainee locations and access for legal representation and families.

Accountability for perpetrators, including military and paramilitary actors.

Implementation of preventive mechanisms such as ratifying and enforcing the International Convention for the Protection of All Persons from Enforced Disappearance.
